## FESTIVAL OF THE ARTS AGREEMENT

This agreement is entered into, by and between the Brownsburg Chamber of Commerce and the Artist named below.

*The artist will comply with the following regulations:*

1. \*Commercially made items for resale **WILL NOT** be allowed. If we find that you have commercially made items, you will be asked to remove those items or tear down immediately and you **WILL NOT** receive a refund.
2. An exhibit is for one exhibitor only or by collaborating artists; and only their joint work may be shown.
3. Exhibits may not be resold.
4. We reserve the right to request removal of any work that differs in nature from the application or pictures submitted as well as any inappropriate works or displays.
5. No responsibility for loss or damages of any artwork or display in the show is assumed by the Brownsburg Chamber of Commerce, the Town of Brownsburg or the Brownsburg Parks Department. We suggest you have liability insurance.
6. Acceptance and participation in the current Festival of the Arts does not guarantee acceptance for the next year's show.
7. Exhibitors must be present at their exhibit during the entire show from 8:00 am – 3:00 pm.
8. Exhibit space requests are handled on a first come first serve basis according to when we receive the application and fees in full. Exhibit space will not be held or guaranteed from year to year.
9. Exhibit set up will begin at 10:00 am on Friday. Everyone must be out of the show area for security reasons by 8:00 pm.

10. Vendors must provide their own tables and chairs and extension cords if electrical hook-up is requested.
11. All exhibits must be completely set up by 7:00 am Saturday morning.
12. I have read all the application information and agree to abide by all the terms, criteria and those described therein. I release the Brownsburg Chamber of Commerce, the Town of Brownsburg and the Brownsburg Parks Department from any liability for damage/loss. I understand that there are no refunds issued after May 1, 2017 or due to inclement weather. This is a rain or shine event. Images of artwork may be used in advertisements.
